The Conference will be held in a **HYBRID** format:

- ✓ Participant with **physical pass** may attend the Conference in-person.
- ✓ Participant with **virtual pass** may attend the Conference virtually via Zoom platform.

### **13. I have registered for physical pass, when will I receive the e-ticket?**

### **14. I have registered for virtual pass, when will I receive the Zoom link?**

Participant who has registered for **virtual pass** will receive one (1) unique Zoom access 3 days before the Conference (if you register before 24 July) or within 24-hour upon registration (if you register on or after 24 July). This link will be emailed to the address you registered with us, so please double check and ensure that your email address is correct at the time of registration. As the Zoom access is unique for each registered participant, no sharing of Zoom access is allowed.
