



## OPENING REMARKS

by



### **DATO SRI FONG JOO CHUNG**

Sarawak State Legal Counsel

Born in Kuching in 1949, he received his early education at St Joseph's School, Kuching, before proceeding, in 1968, to study law at the University of Bristol, England where he obtained his Bachelor of Laws (Hons) in June 1971. He was called to the English Bar by the Honourable Society of Lincoln's Inn in November 1971. He was admitted to practise as an Advocate in Sarawak in January 1972, and remained in private practice with the Law firm of Reddi & Company, Kuching until the end of July 1992.

On 8th August 1992, he was appointed as the State Attorney-General, Sarawak, a position he held until 31st December 2007. Upon relinquishing that position, he has been retained by the State Government of Sarawak in an advisory capacity and continues to represent the State Government in cases before the appellate Courts and the High Court. He sits on the Board of Directors of a number of Corporations wherein the State Government has equity interests, including Bintulu Port Holdings Berhad, Sarawak Energy Berhad, and Syarikat SESCO Berhad. He is a member of the Board of Curtin (Malaysia) Sdn Berhad (which runs the Curtin University Miri Campus) and St Joseph's Private School, Kuching.

From April to October 2022, Dato Sri Fong Joo Chung drafted Sarawak legislations relating to Carbon Capture Utilisation and Storage (CCUS) and Forests Carbon Projects to implement Sarawak's efforts towards reduction in carbon emission and mitigation against the effects of global warming as well as a transition towards a green economy.

He is the author of three books. Two books were published by Thomson- Reuters, namely Constitutional Federalism in Malaysia [2008] and Law on Native Customary Land in Sarawak [2011] and Sarawak Law Series Land Code [with Annotations] published by LexisNexis [2015].

## THE RIGHT HONOURABLE JUSTICE DATO' ABDUL RAHMAN BIN SEBLI

Chief Judge of Sabah and Sarawak

His Lordship Dato' Abdul Rahman bin Sebli was born on 25 January 1959 in Sarawak. His Lordship obtained his Bachelor of Laws (with Honours) from University of Malaya in 1983. Upon graduation His Lordship joined the Judicial and Legal Service of Malaysia in December 1983. Prior to His Lordship's elevation to the High Court of Malaya, His Lordship had served in various capacities in the Judicial and Legal Departments of the Government of Malaysia. Among the posts His Lordship held was that of Deputy Public Prosecutor in the State of Sarawak, Pahang, Kuala Lumpur; Senior Legal Officer at the Sarawak State Attorney-General's Chambers; Sessions Court Judge of Kota Bharu, Kelantan, Kota Kinabalu, Sabah and Miri, Sarawak; State Legal Advisor to the State of Pahang and Director of Legal Division at the Royal Malaysian Customs Putrajaya.

On 15 September 2008, His Lordship was appointed as Judicial Commissioner and on 9 August 2010, His Lordship was elevated to the position of a Judge of the High Court of Malaya. His Lordship served at the High Court Kota Kinabalu, Shah Alam and the High Court at Johor Bahru until His Lordship's elevation to the Court of Appeal. His Lordship was elevated to the Court of Appeal on 12 September 2014.

On 8 August 2019 His Lordship was elevated to the position of a Judge of Federal Court and on 17 January 2023 His Lordship was appointed as the Chief Judge of Sabah and Sarawak.

In recognition of His Lordship's service to the State of Penang, His Lordship was conferred the award of Darjah Indera Mahkota Pahang (D.I.M.P) which carries the honorific title "Dato" by Sultan of Pahang in 2003. His Lordship is married to Datin Sarbanun binti Mokhtar and is blessed with seven children.

Director of Public Works Sarawak

An engineer by profession, Ir.Ts. Richard Anak Tajan received his Bachelor's Degree (Hons) in Civil Engineering from the MARA University of Technology (UiTM), Shah Alam, in the year 1992 and later obtained his Master of Business Administration from Phoenix International University, New Zealand, in the year 2002. He entered the State Civil Service as a Civil Engineer in Jabatan Kerja Raya Sarawak on April 7, 1993 and served in various capacities throughout a distinguished civil service career until his recent appointment as Director of Public Works Sarawak on July 1, 2022. He is a member of the Board of Engineers, Malaysia (BEM), a Member of the Malaysia Board of Technologists (MBOT) as a Professional Technologist (Ts.) and a member of the Board of several Sarawak State agencies and statutory bodies. Throughout his career, he received numerous professional recognition and awards, including: Pingat Perkhidmatan Bakti, P.P.B., Pegawai Bintang Kenyalang, P.B.K., Pingat Perkhidmatan Cemerlang, P.P.C. and Pingat Perkhidmatan Setia, PPS.

As Director of Public Works Sarawak, some of the areas of expertise would likely include: Infrastructure development and maintenance, including roads, bridges, buildings, and public facilities; Construction management and oversight, including planning, design, budgeting, and inspection; Project management and procurement, including the development and implementation of project schedules, budgets, and contracts; Environmental management, including ensuring that construction and maintenance activities comply with relevant environmental laws and regulations; Engineering design and technical support, including providing technical advice and support to other departments and agencies; Emergency management and disaster response, including coordination with other agencies to respond to natural and man-made disasters; Budget preparation and management, including preparation of the annual budget for the department and ensuring that funds are used effectively and efficiently; and Stakeholder engagement and community outreach, including regular communication with stakeholders and community members to keep them informed of departmental activities and initiatives.



Court of Appeal Judge

Justice Dato' Lee Swee Seng graduated with a Bachelor of Laws (Hons) degree from the University of Malaya and obtained his Master of Laws from the same university. He also holds an MBA degree from the University of Southern Cross, Australia. Justice Dato' Lee was called to the Malayan Bar in February 1985 and was in active legal practice until May 2010, when he was appointed a Judicial Commissioner of the High Court of Malaya. He was made a Judge of the High Court of Malaya in 2014 and elevated to the Court of Appeal on 8 August 2019.

Justice Dato' Lee has presented numerous papers and spoken at seminars and conferences on corporate and securities law, intellectual property, construction and adjudication, mediation, contractual disputes and many other topics. He was also a visiting fellow of Taylor University Law School and a part-time lecturer with UM Law Faculty for the LLM Masters Programme. Justice Dato' Lee is a trained advocacy trainer with Bar Council Malaysia for its Advocacy Training Course. He was also the High Court Judge of the Construction Court in Kuala Lumpur from 2016 to August 2019 before his elevation to the Court of Appeal.







### JUSTICE DATO' LIM CHONG FONG

Court of Appeal Judge

Justice Dato' Lim Chong Fong D.S.P.N. has a Bachelor of Science (Building) Honours degree from the National University of Singapore, a Bachelor of Laws Honours degree from the University of London, and a Master of Laws degree from the University of Malaya. He is also a Chartered Arbitrator, Chartered Quantity Surveyor, and Barrister at Law (Middle Temple). He has worked as a Quantity Surveyor in the construction industry and practised as a construction lawyer and arbitrator from 1985 to 2013. He was ranked as the leading lawyer in construction dispute resolution by Chambers & Partners, Asialaw Profiles, and The International Who's Who of Construction Lawyers' legal directories.

He has undertaken research on the security of construction payment as a Fulbright scholar at the William S. Richardson School of Law in Hawaii, USA, and was subsequently appointed by the Construction Industry Development Board Malaysia to formulate the draft Construction payments as a Fulbright scholar at the William S. Richardson School of the Law in Hawaii, USA and subsequently appointed by the Construction Industry Development Board Malaysia to formulate the draft Construction Industry Payment and Adjudication bill (now Act 746 of Malaysia). He was the Honorary Advisor (Contracts) of the Master Builders Association Malaysia and was appointed by the Minister of Works in 2013 as a member of the expert panel to review the Malaysian construction industry practices following the construction accident at the Penang Second Bridge project. In 2017, he was awarded the Lifetime Achievement Award (Quantity Surveying) by the Royal Institution of Surveyors Malaysia. Justice Dato' Lim Chong Fong was appointed Judicial Commissioner on 15th January 2014 and Confirmed as Judge of the High Court of Malaya on 30th January 2017.
