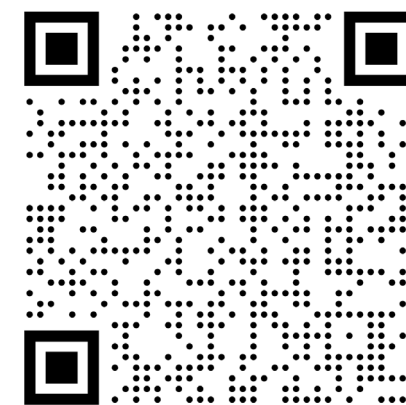

OPENING REMARKS



DATUK SUNDRA RAJOO

Director, Asian International Arbitration Centre (AIAC)

Datuk Sundra Rajoo is the current Director of the Asian International Arbitration Centre (AIAC) and President of the Asian Institute of Alternative Dispute Resolution (AIADR). He is a Certified International ADR Practitioner (AIADR) and Chartered Arbitrator. He played an active role in transforming the AIAC into a sought-after arbitration centre in the Asian region, where the AIAC's caseload grew massively from a mere 22 arbitration cases in 2010 to an accumulative total of 2761 arbitration, adjudication and mediation cases in 2019. He was also the past President of the Chartered Institute of Arbitrators (2016) and past Chairman of the Asian Domain Name Dispute Resolution Centre (ADNDRC). He has a number of tertiary degrees in law, architecture and town planning with Hon LLD. He is the Founding President of the Sports Law Association of Malaysia, Founding President of the Society of Construction Law, Malaysia and the Malaysian Society of Adjudicators; and Past President of the Asia Pacific Regional Arbitration Grouping (APRAG).

Datuk Sundra is an Advocate & Solicitor of the High Court of Malaya, a Registered Professional Architect, a Registered Town Planner, and a Fellow of the Royal Institution of Surveyors. He has had over 310 appointments in international and domestic arbitrations across numerous international arbitral institutions. He was an Adjunct Professor, Law Faculty of the University of Malaya, past Visiting Professor at the Faculty of Built Environment, University of Technology and the Law Faculty, National University of Malaysia. He was a pioneer member of the Monetary Penalty Review Committee set up under the Malaysian Financial Services Act 2013 for two terms. Datuk Sundra is a former Deputy Chairman of the Adjudicatory Chamber of the Ethics Committee of the FIFA Council. Datuk Sundra has authored, co-authored and edited Law, Practice and Procedure of Arbitration, 2nd Ed, 2016, Lexis Nexis (LN); Arbitration in Malaysia: A Practical Guide, 2016, (S&M); Construction Law in Malaysia, 2012, S&M; The Malaysian Arbitration Act 2005 (Amended 2011) - An Annotation, 2013, LN; The PAM 2006 Form, 2010, LN; The Arbitration Act 2005 - UNCITRAL Model Law as Applied in Malaysia, 2007, S&M; The Malaysian Standard Form of Building Contract (The PAM 1998 Form), 1999, Malayan Law Journal. In 2015, he was conferred an Honorary Doctorate in Laws from Leeds Beckett University, UK. He recently published the Law, Practice and Procedure of Arbitration in India (Thomson Reuters) and Standard Form of Building Contracts Compared (LexisNexis).

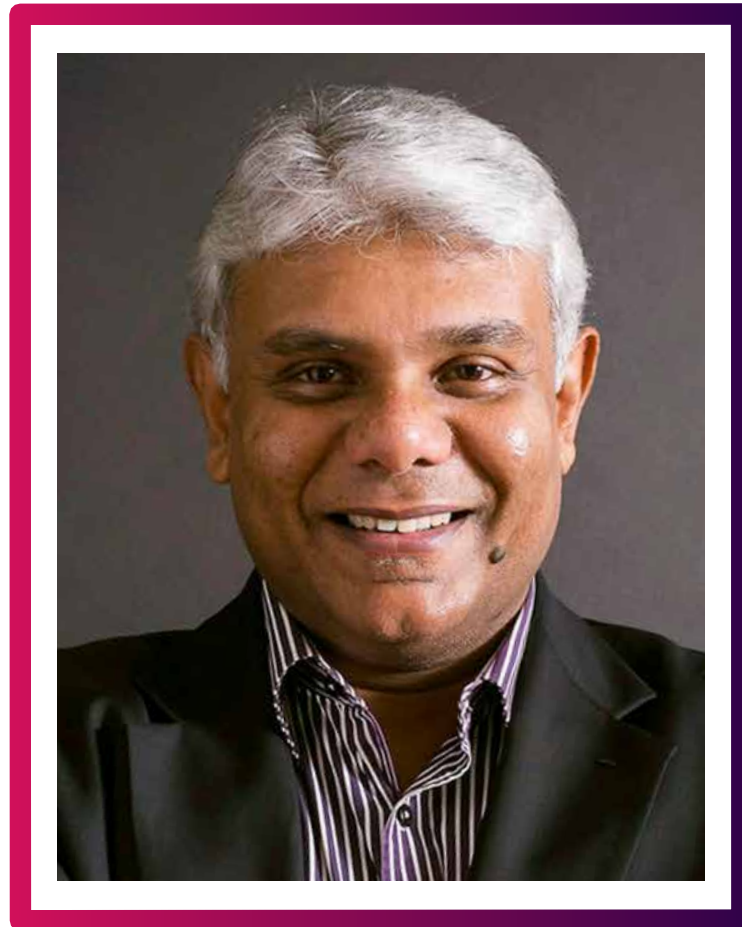
KEYNOTE ADDRESS



JUSTICE DATO' MARY LIM THIAM SUAN Federal Court Judge of Malaysia

Justice Dato' Mary Lim Thiam Suan read law at the University of Leeds, UK and graduated with an LLB (Hons) degree. She has been admitted to Lincoln's Inn as a Barrister-at-law. In 1993 she obtained her Master of Laws degree from the University of Western Australia. Prior to her elevation to the High Court of Malaya, where she sat in the New Commercial Court, her Ladyship served in various capacities at the Attorney General's Chambers of Malaysia. These include as Federal Counsel, Senior Federal Counsel, Senior Assistant Parliamentary Draftsman, Legal Advisor to the State of Negeri Sembilan, Deputy Head of Civil Division and Commissioner of Law Revision and Law Reform. Justice Lim was the first judge of the Construction Court in Kuala Lumpur until her Ladyship's elevation to the Court of Appeal. She is now a Judge of the Federal Court of Malaysia.

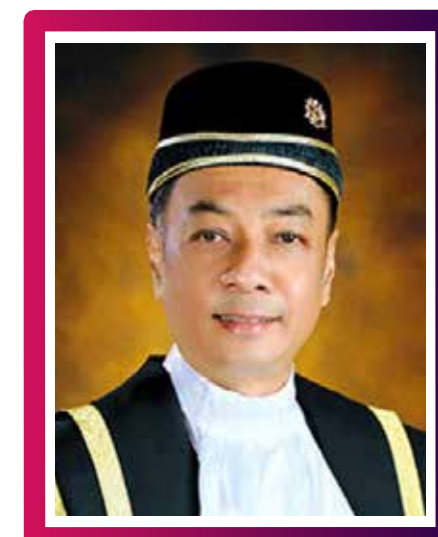

JUSTICE DATUK WONG KIAN KHEONG Court of Appeal Judge of Malaysia

Justice Datuk Wong Kian Kheong graduated with a Bachelor of Laws (First Class Honours) degree from University of Malaya (UM) in 1988. Thereafter he was awarded a scholarship from Cambridge Commonwealth Trust-Shell Group of Companies to pursue his Master of Laws (Honours) degree in University of Cambridge in 1989. He was called to the Malaysian Bar in March 1990. He then joined the Judicial and Legal Service where he served as a Deputy Public Prosecutor (DPP) in the Attorney General's Chambers (AGC) until he commenced private practice in December 1997. Justice Wong had been awarded Excellent Service Award twice when he was a DPP in AGC. He had represented Malaysia in various conferences on, among others, the drafting of the United Nations' Rome Statute of the International Criminal Court, treaties on extradition and mutual legal assistance in criminal matters. He had lectured on a part-time basis in UM's Law Faculty and Brickfields College. Justice Wong was the editor for Mallal's Monthly Digest and Annotated Statutes of Malaysia as well as a case reporter for Malayan Law Journal. He had also served as a Course Outline Reviewer, Examination Question Setter and Examiner for the Certificate in Legal Practice conducted by the Legal Profession Qualifying Board (QP). When he was in practice, he had served as a Chairman of the Disciplinary Committee and had acted pro bono for QP, Bar Council and Disciplinary Board. He had also been appointed to act for Bank Negara Malaysia, Selangor State Government, Malaysian Highway Authority, Langkawi Development Authority and UM. Justice Wong was appointed a Judicial Commissioner in June, 2014 and then a Judge in April 2018. Prior to his elevation to the Court of Appeal in January 2023, he was attached to the Shah Alam Construction Court. He has given talks on various topics organized by, among others, Judicial Academy, Judicial and Legal Service Training Institute, Kuala Lumpur Bar, Selangor Bar, Inns of Court of Malaysia and Malaysian Intellectual Property Corporation. He is also a trainer for advocacy courses organized by the Malaysian Bar.

Justice Dato' Aliza Sulaiman graduated with a Bachelor of Laws degree from the Australian National University, Canberra, in 1989 and obtained a Master of Laws (With Distinction) from University Malaya in 2005. Her Ladyship was admitted as an advocate and solicitor of the High Court in Malaya in November 1989 and thereafter joined the Judicial and Legal Service, where her Ladyship served as a Magistrate, Legal Advisor, Public Service Department and Economic Planning Unit, Prime Minister's Department ('PMD'); Senior Federal Counsel and Deputy Head, International Affairs Division, Attorney General's Chambers ('IAD'); Director, Certificate in Legal Practice Examination, Legal Profession Qualifying Board; Penang State Legal Advisor; and Senior Director, Legal Section, Public Private Partnership Unit, PMD.
